REQUEST FOR TRADING HALT

Folkestone Limited requests a trading halt from the commencement of trading on 23 March 2011 pending finalisation of the details of the first component of the proposed capital raising which was approved by shareholders at the general meeting held on Wednesday 9 March 2011. For the purposes of ASX Listing Rule 17.1, Folkestone provides the following information:
