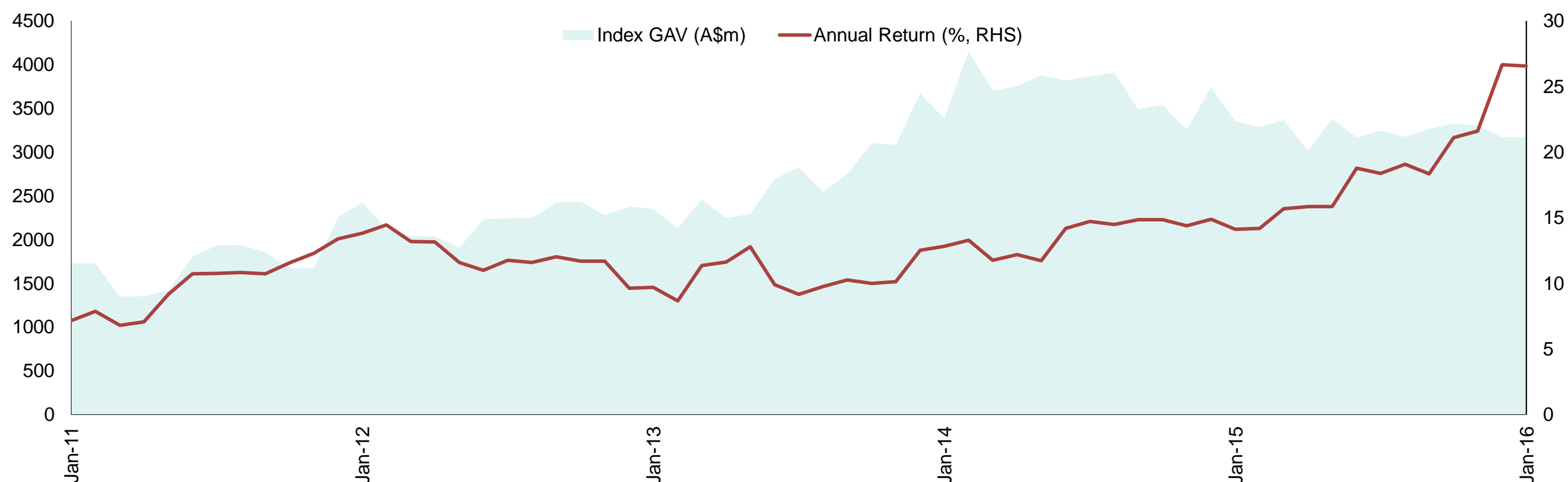

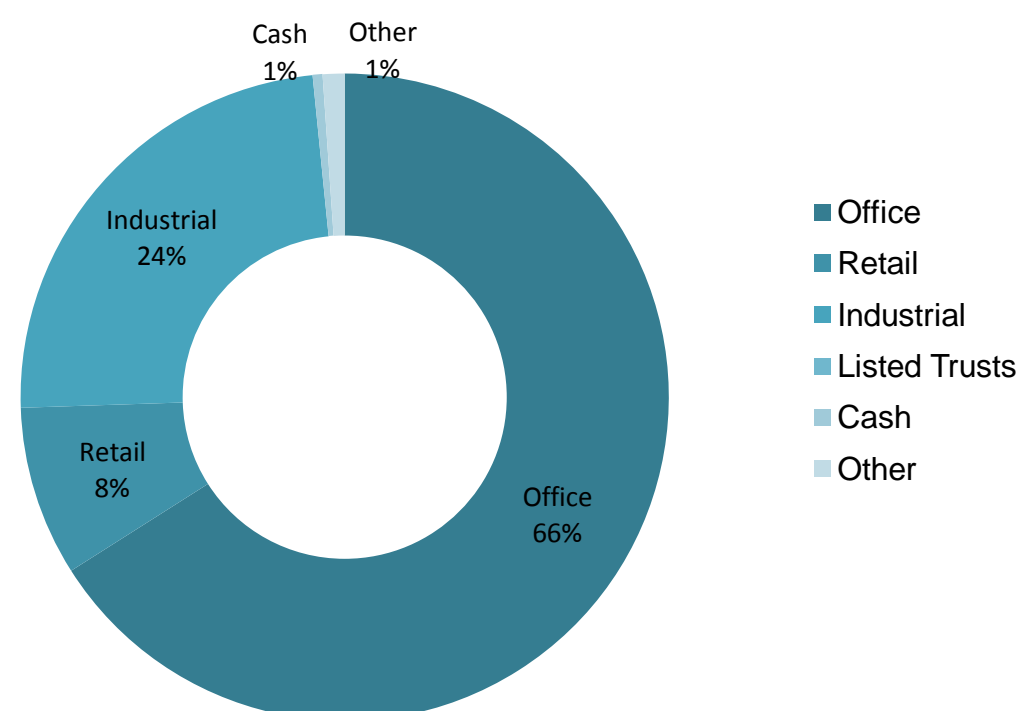

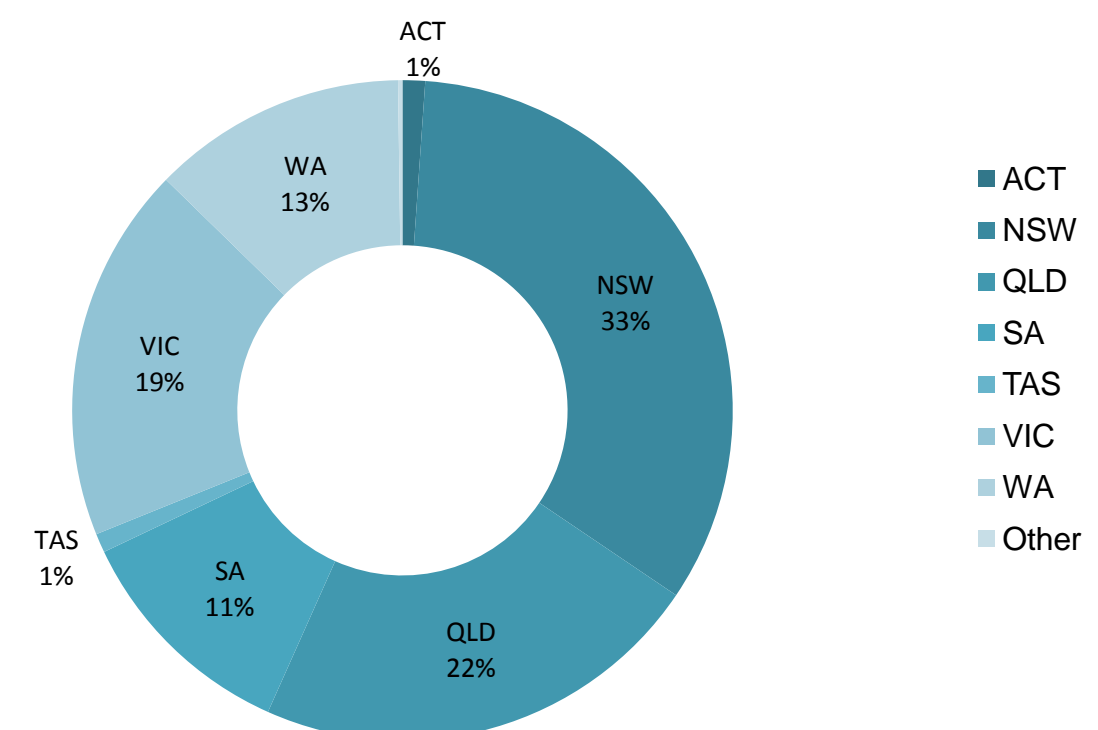
## Sector Allocation
